DESCRIPTION

Workwear bib pants fit perfectly thanks to ergonomically shaped COMFORT FIT cut. Sturdy canvas tearproof fabric has a great mechanical characteristic and tensile resistance. Stretchy waistband with sew-in rubber band allows comfortable wearing; 2 front slit pockets, 2 back flap pockets, mobile phone pocket, pockets for the snap-off knife, screwdriver, carpenter pencil; big slit flap pocket on the left leg; pocket for the folding rule, screwdriver and snap-off knife on the right side. The reflective piping in the knee area for better visibility. Doubled fabric in the knee area, elastic braces, an inner slit pocket on the bib. In combination with reflective fabric, the garment increases wearer conspicuity.
