DESCRIPTION

Workwear pants with knee pad pocket fit perfectly thanks to ergonomically shaped COMFORT FIT cut. Sturdy but lightweight twill fabric with lowered weight has a great mechanical characteristic and tensile resistance. Stretchy waistband with sew-in rubber band allows comfortable wearing, 2 front slit pockets, 2 rear flap pockets, pockets for the snap-off knife, screwdriver, carpenter pencil; big slit flap pocket on the left leg; pocket for the folding rule, screwdriver and snap-off knife on the right side, mobile phone pocket with zipper, doubled fabric in the knee area, reflective piping on the front and back side.
