DESCRIPTION

Workwear bib pants with multifunctional pockets and possibility to use certified knee pads. The garment fits perfectly thanks to the ergonomically shaped COMFORT FIT cut. Solid cannesse fabric has excellent mechanical properties such as high tensile strength and tear resistance. Elastic waist with integrated rubber increases wearing comfort, additionally, there are 2 front tactile pockets, 2 back pockets covered with pocket flaps, large tactile pocket on the left leg covered with a flap, 1 zipper pocket for mobile phone up to 6.5", pocket for a break-off knife, screwdriver and carpenter's pencils, on the right leg pocket for a folding ruler, screwdriver and a cutter, reinforcement made of CORDURA[®], double parts in the knee area and pocket for knee pads, reflective waistband on the front and back for higher visibility, triple stitching in stressed parts for better durability. Excellent ergonomics and maximum freedom of movement are provided by the TABIFLEX[®] stretch technology used in exposed areas of clothing. 2 zippers with mesh allow ventilation of the legs at variable temperatures during the working day.
